#### January 7th - Rotarian John Franke A Non-Partisan Guide to Impeachment

Is it possible to have a non-partisan discussion about impeachment? Former Circuit Court Judge John Franke believes the answer is "yes," and will ring in the New Year with a cheerful look at the ultimate check and balance given to us by our Constitution. The President cannot fire Congress; why is it that Congress has the power to send the President packing? In what ways is an impeachment quite different than a criminal proceeding? What should we expect of our elected representatives in what has been a highly partisan process? We will have a highly non-partisan discussion about the history and development of our impeachment procedures and consider why an impeachment need not so divide us.

#### RCM SCHOLARSHIP APPLICATION NOW AVAILABLE ONLINE

This year, the RCM Scholarship Committee has moved the application process online! This simplifies the process for students to submit their application.

The RCM Scholarship program is based on a holistic approach to serving students who have the motivation and drive to seek higher education. In addition to a financial award, scholarship recipients receive study skills coaching prior to enrollment as well as the support of a mentor throughout their scholarship experience.

RCM mentors give guidance, career and personal advice, and help in navigating the college experience. They are the program's greatest resource and are committed to building a supportive relationship with their scholars.

The amount of a financial aid is determined on an annual basis. Recent awards have ranged from \$2,500 and \$4,500 per academic year. With satisfactory academic achievement, scholarships may be renewed annually.

Applications for the RCM Scholarship are to be submitted electronically via the link on the Rotary website by March 1, 2020.

#### Applicants must:

- Have achieved a GPA that will qualify them for entry into an appropriate institution. (Rotary does not have specific requirements for academic achievement.)
- Demonstrate financial need.
- Live in the City of Milwaukee.
- Complete the application in full, include letter(s) of reference, and an original essay.

#### **REFLECTIONS ON 2019 (CONT'D)**

Throughout the year, the club leveraged the resources of the **RCM Community Trust** and:

- Joined other community leaders to develop programming for MKE Urban Stables and prepare for an early 2020 opening.
- Awarded 25 scholarships. Raised over \$80,000 through the Scholarship Golf Classic.
- Learned that Mike and Christy Kellman included our scholarship program in their estate plan.
   Celebrated a \$50,000 increase in the Gordy and Elizabeth Smith Scholarship.
- Hosted five Serbian public officials to learn about best practices in waste water management.
- Completed our pledges of \$50,000 for the restoration of Milwaukee Soldiers Home and \$50,000 for the renovation of the Grand Theater—the new home for the Milwaukee Symphony Orchestra.
- Committed \$50,000 to a major campus renovation at the Marcus Center for the Performing Arts.
- Planted 100 trees in the Milwaukee Rotary Centennial Arboretum. Sponsored HKE MKE—a community walk through the Arboretum.
- Sponsored a film, Give Me Liberty, at the Milwaukee Film Festival.
- Continued a strong partnership with Engineers without Borders. Saw the completion of a rural water system and grade school. A dozen Rotarians traveled to the highlands of Guatemala.
- Donated \$11,000 for hurricane relief in the Bahamas and over \$12,500 to eradicate polio.
- Distributed 10,000 books to students in 5 schools.
   Tutors worked with students at Brown Street
   Academy.
- Hosted an energized On the Table discussion in October at Johnsons Park.
- Cleaned up the Milwaukee River, rang bells for the Salvation Army and packed food at Feeding America.
- Provided financial support and volunteers for the McKey Christmas Club.
- Hosted 750 guests at our lunch meetings and welcomed 40 new members.
- Found new ways to tell the Rotary story including partnering with the BizTimes and GoGedders to grow distribution of our weekly program podcasts.

## SPOTLIGHT ON THE RCM COMMUNITY TRUST

#### **RCM COMMUNITY TRUST SUPPORTS THE MKE URBAN STABLES**

In 2017 the Rotary Club of Milwaukee joined other community leaders to develop the Lincoln Avenue Stables—now known as MKE Urban Stables to highlight its location in the heart of our city.

MKE Urban Stables offers a unique opportunity to achieve three goals at once – a much needed home for the Milwaukee Police Department Mounted Patrol, a center for trauma-informed equine assisted therapy in the City of Milwaukee, and a platform for police/community relations using horses as a citywide draw.

The Stables facility will house up to 12 Milwaukee Police Department Mounted Patrol horses and up to 12 equine assisted therapy horses.

Construction of the Stables facility began in April 2019, with the Stables **anticipated to open in early 2020**, when the Mounted Patrol will take up residence in the Stables.

The **equine assisted therapy** program is planned to phase into full strength over a three-year period beginning in 2020, with an initial focus on trauma informed therapy for veterans and other community members.

The Milwaukee Police Department plans to use MKE Urban Stables as a focal point for community relations and outreach efforts. Anticipated programming includes: (1) service learning programs built around the care of horses, for high school students with an initial focus on students in the JROTC program at Hamilton High School, (2) experiential learning programs built around horses, horsemanship, and the civic role of law enforcement, for elementary and intermediate school students, and (3) learning and dialogue programs for youth and police to promote community healing.

#### **OUICK FACTS**

**Location:** Located on the southeast corner of First Street & Lincoln Avenue on four acres donated by the city. The Stable will enhance the community connection in the Harbor District neighborhood.

**Project Cost:** The current estimate of total construction costs for the Stables project is \$5.65 million, with \$5.5 million (97% of the total) secured to date, including our Club's \$250,000 pledge. Fundraising efforts are ongoing for the balance of construction costs.

**Governance:** MKE Urban Stables, Inc., a non-profit corporation, will oversee the equine assisted therapy program and, in cooperation with the Milwaukee Police Department, will run police/community relations programs from the Stables. The Board of Directors of MKE Urban Stables, Inc. includes four of our Club members, along with other Milwaukee business and community leaders.

**Volunteer Opportunities:** Rotarians will be able to find meaningful ways to contribute their time and their talents including nonprofit board membership, assisting with equine-assisted therapy programs, and co-facilitating youth programming with the MPD.
